Notice of transfer of the business enterprise of BATIST Medical Productions s.r.o.

Dear All,

We hereby inform you that on 18 September 2024, **AZAM - insolvency, v.o.s.**, ID No.: 087 77 993, with its registered office at Opletalova 1417/25, Nové Město, 110 00 Prague 1 (the "**Seller**"), as insolvency trustee of **BMP zbytková s.r.o.** (originally BATIST Medical Productions s.r.o.), a limited liability company established and existing under the laws of the Czech Republic, with registered office at Nerudova 744, 549 41 Červený Kostelec, Czech Republic, ID No.: 465 07 850 ("**BMP**"), as seller, and **BATIST Medical Productions s.r.o.** (originally C3P1 Medical s.r.o.), a limited liability company established and existing under the laws of the Czech Republic, with its registered office at Nerudova 744, 549 41 Červený Kostelec, ID No.: 219 50 784 (the "**Buyer**"), as buyer, entered into the contract for sale and purchase of business enterprise (the "**Contract**"), on the basis of which the Seller transferred to the Buyer and the Buyer acquired the ownership right from the Seller to the business enterprise of BMP with the exception of some individual items, which were within the meaning of Section 2175 paragraph 1 of Act No. 89/2012 Coll., the Civil Code, as amended, excluded from the transfer (the "**Enterprise**").

The ownership right to the Enterprise was transferred from BMP to the Buyer on 1 November 2024 (the "**Effective Date** "). At the same time as the acquisition of the ownership right to the Enterprise, the Buyer, as of the Effective Date, became, among other things, a creditor of claims instead of BMP, which belongs to the Enterprise and a person entitled from any related collateral.

We would like to inform you that all rights and claims of BMP against you and your contract(s) and related legal relationships with BMP belong to the Enterprise and as such passed from BMP to the Buyer.

As of the Effective Date, the Buyer became your creditor from all existing and future claims from the above legal relationships. At the same time as of the Effective Date, the Buyer with the original business

name “C3P1 Medical s.r.o.” changed its business name to “BATIST Medical Productions s.r.o.” and its registered office to Nerudova 744, 549 41 Červený Kostelec.

In relation to the abovementioned, we inform you that from the delivery of this notice, you shall discharge your obligations to and otherwise act exclusively towards the Buyer in relation to all legal relationships mentioned above. The correspondence and bank details remain the same and there were changes only in the ID No. (which is now ID No.: 21950784) and VAT ID No. (which is now VAT ID No.: CZ21950784), under which the Enterprise of BMP will continue to be operated.

This notice is made in accordance with the provisions of Section 2177 of Act No. 89/2012 Coll., the Civil Code, as amended.
